This is with reference to your letter dated 21.03.2024 on the above mentioned subject and it is informed that a fresh proposal for nomination of Vice-Chairperson has been forwarded to the DoPT vide letter dated 18.03.2024. Regular reminders are being sent to State Governments/UTs for constitution of State Allied and Healthcare Councils. Recently, a reminder DO letter has been sent on 19.03.2024 to Principal Secretaries of State/UTs. A review meeting was also held with States/UTs on 11.03.2024 to discuss the various issues of State Councils. It is further stated that a letter to State Government/UTs has also been sent on 06.03.2024 to furnish nomination for part-time member under Section 3(3)(d)(i) of the Act. The matter of nomination of charitable institutions under Section 3(3)(d)(iii) is under process.
